PURPOSE: To enable deputized staff to obtain arrest, investigative and traffic

information, on youth from Los Angeles County Central Juvenile Index at

the Los Angeles County Probation Department.

I. PROCEDURE

A. Los Angeles County Central Juvenile Index

- 1. To determine whether a youth is an active or inactive ward in Los Angeles County, contact the Los Angeles County Probation Department Information Center via phone (1-866-931-2222) or email (pic@probation.lacounty.gov).
- 2. Identify yourself and this department and then specify if the record check is either juvenile or adult.
- 3. Similar to our agency's own records procedure, they will only release limited information and then refer you to the assigned deputy probation officer (DPO) or Officer of the Day.

B. Juvenile Traffic Records

There are three (3) ways to request Los Angeles County Juvenile Traffic records:

- If a youth receives a stand-alone vehicle code infraction violation, the citation is filed in adult court in the court that handles the jurisdiction in which the violation occurred. For more information, refer to: http://www.lacourt.org/courthouse/mode/division/traffic
- 2. If the infraction (vehicle code or non-vehicle code) is filed in conjunction with a misdemeanor or felony violation, it stays with the more serious offense in juvenile court.
- 3. If the youth receives a stand alone, non-vehicle code violation, it is handled by the Los Angeles County Probation Department. These records may only be obtained in person or via the United States Postal Service utilizing the *Declaration in Support of Access to Juvenile Records* (LAJUV 010) form.
