- **PURPOSE:** To establish the procedure by which deputized probation staff can ensure client compliance with palm/fingerprints via Live Scan and DNA collection statutes, as well as maintain accurate and timely information in the Integrated Case Management System (ICMS) regarding the status of each client who is required by law to submit to DNA sampling.

## I. GENERAL INFORMATION

- A. Pursuant to PC 296, any person, including any juvenile, who is convicted of or pleads guilty or no contest to any felony offense, or is found not guilty by reason of insanity of any felony offense, or any juvenile who is adjudicated under Welfare and Institutions Code (WIC) 602 for committing any felony offense, or since January 1, 2009, adults who have been arrested for a felony or of a registrable misdemeanor PC 290 (Sex Offense Registration) or of registrable PC 457.1 (Arson) offenses, must submit their persons to law enforcement for collection of palm and thumbprints via Live Scan and DNA samples. These samples are sent to the Department of Justice (DOJ) DNA Data Bank. Collection may only occur while the qualifying person remains legally subject to government supervision or control.
- B. The Orange County Sheriff's Department **(OCSD)** and the Orange County Probation Department are responsible for collection of prints and DNA samples from qualifying persons under the supervision of the Orange County Probation Department.
- C. The **OCSD** will collect DNA samples from qualifying adults while in their custody. Police agencies will collect DNA from qualifying adult arrestees.
- D. DNA samples, palm, and fingerprints (via Live Scan) are not to be collected when any other law enforcement agency or Department of Corrections has already collected a DNA sample. In those cases, the deputy probation officer (DPO) has only to confirm the collection and to record it in ICMS, if this has not already been

done. Once a sample has been taken from an individual, no further samples are needed.

E. Qualifying **clients** who have not already submitted DNA samples are to be referred to the designated probation office.

## II. PROCEDURE

- A. Procedure to verify that DNA and prints are mandated
  - 1. Upon receiving a new case, DPOs are to determine whether the **client** who is under their supervision is mandated by statute to provide a DNA sample, palm, and fingerprints (via Live Scan).
    - a. The DPO should review the current convictions, as well as the prior record of the client for any past felony or registrable misdemeanor offenses. The DPO needs to double check "wobblers" to ensure the conviction offense was not subsequently reduced to a nonregistrable misdemeanor offense. Motions pursuant to Penal Code (PC) 17(b) do not disgualify for DNA sample collection.
    - b. If the client has any qualifying offense(s), a DNA sample and palm/fingerprints are required for the DOJ database. A list of qualifying offenses can be found attached to this Procedure Manual Item (PMI) or on the under the *Application* tab. Once there, go to the section and open the

. The list can be found just

underneath the *Help* button on the

page. A query identifying those who have submitted samples can also be found there by following the directions on the screen by entering in the first and last name of the **client**. The list is in alphabetical order by last name; however, care needs to be taken to check the <u>entire</u> list since there are several lists that are merged and the first names are not entirely in alphabetical order. This includes checking past a person's name the first time it should appear on the list.

- 2. The DPO shall not refer the case for collection until it is confirmed that a DNA sample or palm/fingerprints have not been provided in the past. If a sample has previously been collected, the assigned DPO must update ICMS to show that a collection is not needed. Clients who have recently been processed through the Orange County Jail for new law violations or probation violations may have already submitted to DNA collection with OCSD.
- B. Procedure to determine if a sample has been previously taken
  - 1. It is beneficial to question the **client** as to whether or not they have provided a sample during a recent incarceration as the site may not have the

sample recorded soon after a release from custody. If the **client** indicates

that a sample was taken, the DPO shall wait thirty (30) days and recheck prior to referring the **client** to MOB 5<sup>th</sup> Floor for sampling.

- 2. Check ICMS by looking at the **client's** *Flags/Case Plan* section, in the *Special Indicators and Case Plan Actions* sections, as the Probation Department may already have confirmation of a sample noted.
- 3. The precord check or will often reflect whether a sample has been collected in the past. If so, this is considered confirmation.
- 4. The same page from the same site can be used to find out if the **client** has previously provided a sample *locally in Orange County* only.
- 5. The **DOJ** can be contacted to determine if a **client** has provided a DNA Sample anywhere in the state by calling will answer. Identify yourself and agency then provide the **client's** number and name. The as they cannot look it up.
- C. Procedure if a sample is on file, but not recorded in ICMS
  - 1. The assigned DPO is required to update information in ICMS by going into the section. There are two DNA tested by... lines (by OC Probation and by Outside Agency). Once the DPO has verified that DNA has been taken by an outside agency, the DPO clicks on the arrow to the left of DNA tested by Outside Agency. A box will open up. The DPO should enter the information in the box (e.g., DNA verified through DOJ).
  - 2. Those samples collected by the probation department will be entered in ICMS following Quality Assurance System (QAS) review.
- D. Procedure for Live Scan and/or DNA sampling pursuant to PC 296

If a Live Scan and/or DNA sample is required but not yet completed, the assigned DPO is to ensure that the **client** is referred, confirmation is received, and the information is verified by ICMS. The assigned DPO must:

- Complete the automated form entitled DNA Admonishment Notification in ICMS under "Adult" for adults and "Juvenile" for juveniles. Select the dropdown arrow for either category. Scroll down to Reports and hover the cursor over Reports. Click on the DNA Admonishment Notification form. Enter the client's J, DL, or A number, as well as requested information. Then select Generate Form to create the form. Then select Email Notification and the form will automatically be forwarded to the DNA Clerk located at MOB.
- 2. The DPO is to ensure that the admonishment is completely filled out; verifying that the qualifying charge is noted. Print two (2) copies, which are to be signed and dated by both the DPO and the **client**.

- 3. Give one (1) copy of the Admonishment Notification form to the **client**. This will provide them with information on where and when to report for DNA Sampling within five (5) days of receipt.
- 4. Direct the **client** to bring their copy of the signed admonishment form with them and valid photo identification when they report for collection. The other signed copy is retained in the **client's** file.
- E. Procedures for DPOs collecting DNA and Live Scan samples
  - 1. The MOB 5<sup>th</sup> Floor Officer of the Day (OD) is responsible for collecting DNA and Live Scan samples during their assigned OD shift. The OD DPO is to verify the **client's** identity using picture identification or other administrative means. If the identity of the **client** cannot be verified, the DPO may request the **client** to return at a later time with appropriate documentation.
  - 2. Collect DNA sample as described in the DNA and Live Scan Desk Manual.
  - 3. If palm and fingerprints need to be collected via Live Scan, the DPO is to log into the Live Scan using their unique user name and password. Input and collect prints as described in the DNA and Live Scan Manual.
- F. Procedure once DNA and Live Scan samples have been taken
  - 1. Once the DNA Clerk receives the automated DNA Admonishment Notification form and the sample is taken, they will record it in ICMS and TracKRS/SciLas and forward it to the Department of Justice for inclusion in their database.
  - 2. Failure to comply with DNA Collection
    - a. The assigned DPO is to ensure the **client** has reported for DNA collection by checking ICMS as mentioned above. The DNA Clerk will notify the referring DPO who sent the request form if the **client** failed to submit to DNA collection within five (5) days.
    - b. Failure to submit to DNA collection is a violation of the law pursuant to PC 298.1. If the **client** fails to submit a DNA sample or Live Scan, the DPO will determine, based on case dynamics, whether to arrest the **client** for violation of probation or to allow the **client** to reschedule another appointment.
    - c. PC 296 states that failure to provide DNA samples within five (5) days of admonishment is punishable by one (1) year in custody and a \$500.00 fine.
- G. Supervising Probation Officer (SPO) Responsibility

Prior to any case being transferred or terminated, SPOs will **e**nsure that DPOs have complied with the procedure as listed above related to the collection of DNA.

# H. Sealing of Juvenile Records Pursuant to Welfare and Institutions Code (WIC) 786

Pursuant to PC 299, when a youth's record is ordered sealed and there was DNA collected in regard to the matter that was sealed, it is the responsibility of the youth to petition DOJ to have their DNA sample destroyed and searchable database profile expunged from the data bank program.




