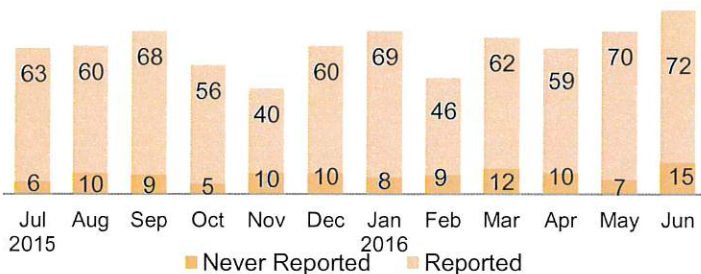

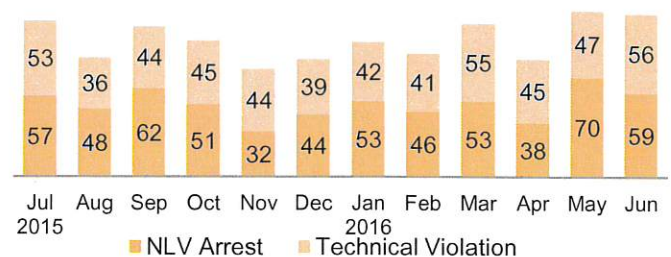


Revocations

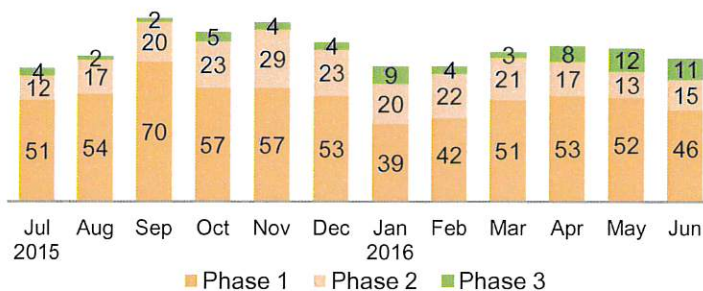

2016 Monthly Avg = 73

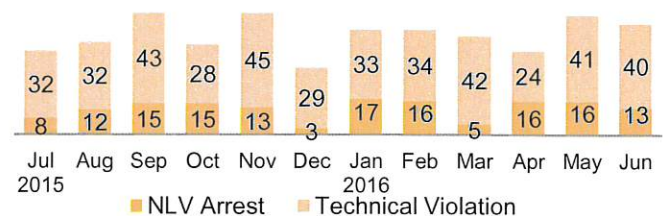

Members of the media are invited to attend a multi-agency homeless outreach event this Saturday, July 30, 2016, starting at 10:00 a.m. in the parking lot of **7861 Garden Grove Boulevard**, just west of Beach Boulevard in Garden Grove. Please note the recent change of location for this event.

According to the Garden Grove Police Department, homeless and mental health-related calls increased more than 40% over the last year in Garden Grove. The Police Department is teaming up with law enforcement agencies from Westminster, the Orange County Sheriff's Department, and Anaheim to coordinate an event providing assistance to the homeless community. Services such as transitional housing programs, recovery assistance, mental health treatment, employment, and veteran services will be available for the homeless.
